**Scrutinizer's Report on Postal Ballot voting by way of remote e-voting by electronic means in
respect of passing of the special resolution set-out in the Notice dated 05th December, 2025 through
Postal Ballot**

Dear Sir,

I, Neelesh Kumar Jain, Company Secretary in Practice (FCS: 5593/ CP No. 5233), has been appointed as Scrutinizer by the Board of Directors of Uniparts India Limited ("the Company") for the purpose of scrutinizing the Postal Ballot voting conducted by way of remote e-voting process ("e-voting") in a fair and transparent manner on the special resolution contained in the postal ballot notice dated 05th December 2025 ("Notice") issued in accordance with General Circular Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 20/2020 dated May 5, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021, 20/2021 dated December 8, 2021, 3/2022 dated May 5, 2022, 11/2022 dated December 28, 2022, 09/2023 dated September 25, 2023, 09/2024 dated September 19, 2024 and 03/2025 dated September 22, 2025, issued by the Ministry of Corporate Affairs, ("MCA"), Government of India (hereinafter referred to as "MCA Circulars").

1. In compliance with the MCA Circulars, the Notice was sent through electronic mode to equity shareholders whose email address is registered with the Company/ Registrar & Transfer Agent of the Company, MUFG Intime India Private Limited (MUFGINTIME)/ National Securities Depository Limited ("NSDL") / Central Depository Services (India) Limited ("CDSL") / Depository Participants as on Friday, December 19th, 2025 ("Cut-Off Date").

The said Notice was also placed on the website of the Company at: www.unipartsgroup.com, and on the website of the Stock Exchanges, i.e., BSE Limited and National Stock Exchange of India Limited at www.bseindia.com and www.nseindia.com, respectively; and on the website



of MUFGINTIME (the Registrar and Transfer Agent of the Company, being the agency appointed by the Company to provide to its equity shareholders facility to exercise their right to vote on the resolutions contained in the Notice) at <https://instavote.linkintime.co.in/>.

In compliance with the relevant MCA Circulars, a newspaper Advertisement was published on Sunday, December 28, 2025 in Financial Express (English) and Jansatta (Hindi) specifying the details of dispatch of Notice and instructions for e-voting.

2. The said appointment as Scrutinizer is under the provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended ("the Rules"). As the Scrutinizer, I have to scrutinize the process of e-voting conducted for the postal ballot, using an electronic voting system on the dates referred to in the Notice.

Management's Responsibility

3. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA Circulars; and (iii) the SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015, ("LODR") relating to e-voting on the resolution contained in the Notice. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.

Scrutinizer's Responsibility

4. My responsibility as a Scrutinizer for e-voting process is restricted to making a Scrutinizer's Report of the votes cast "in favour" or "against" by the equity shareholders in respect of the resolution contained in the Notice, based on the reports generated from the e-voting system provided by MUFGINTIME, the Registrar and Transfer Agent of the Company and the Agency authorized under the Rules and engaged by the Company to provide e-voting facility and attendant papers/ documents furnished to me electronically by the Company and/ or MUFGINTIME for my verification.

Cut-Off date

5. The equity shareholders of the Company as on the Cut-Off Date, as set out in the Notice, i.e., Friday, December 19th, 2025 were entitled to vote on the special resolution (item no.1, as set out in the Notice) and their voting rights were in proportion to their shareholding in the paid-up equity share capital of the Company as on the Cut-Off Date, subject to the provisions of Articles of Association of the Company.


6. Remote e-voting process

- i. The remote e-voting period remained open from Sunday, December 28, 2025 at 9.00 AM. (IST) to Monday, January 26, 2026, at 5.00 P.M. (IST).
- ii. The votes cast during the remote e-voting period were unblocked on Tuesday, January 27, 2026 after the conclusion of e-voting period for Postal ballot and was witnessed by two witnesses, Ms. Beauty Jaiswal and Ms. Divyot Kaur, who are not in the



employment of the Company and / or MUFGINTIME. They have signed below in confirmation of the same.

iii. Thereafter, the details containing, *inter alia*, the list of equity shareholders who voted "in favour" or "against" on the special resolution, were generated from the remote e-voting website of MUFGINTIME i.e., <https://instavote.linkintime.co.in>. 
Based on the aforesaid results, I report that the Special resolution as set out in item no. 1 of the Notice has been **passed with requisite majority**.
